### ORDER

As per paper read (1), a one time Re - examination is being permitted in the eighth semester of all UG programmes, for the courses of 5<sup>th</sup> and 6<sup>th</sup> semesters. The provision is available for 2016 admission UG batches onwards.

As per the approved syllabus for the B.Tech. (Food Technology) degree programme, Major, Minor and Elective courses for a total credit of 20 are included in the Seventh semester of the programme which necessitates the provision of One time re-examination in the eighth semester for the courses of the 7<sup>th</sup> Semester, also.

In view of the above, as per paper read (3), the Academic Officer (UG) moved a resolution in the 50<sup>th</sup> Board of Studies (BOS) meeting of Faculty of Engineering and Technology, to permit a one-time re-examination in the 8th semester for courses of 5<sup>th</sup>, 6<sup>th</sup>, and 7<sup>th</sup> semesters of B.Tech (Food Technology) program. This provision

ensures that students in their final (8<sup>th</sup>) semester will be having a chance to clear their backlogged courses, without delaying their graduation.

The Board of Studies recommended the proposal to the Academic Council.

As per the provisions laid down in the University statute vide (3), the Board of Studies has the powers to make recommendations in regard to the course of study and examinations in the subject with which it deals.

The Academic Council as per paper read (5) has approved the proposal.

As per provisions laid down vide (4), the Academic Council have the control and general regulation and be responsible for the maintenance of standards of instruction, education and examination within the University.

In the above circumstances, in consonance with the decision of Academic Council , the following orders are issued in partial modification to the University Order cited (1).

A one time re-examination will be permitted in the 8<sup>th</sup> semester of B. Tech. (Food Technology) degree programme, for the courses of its 5<sup>th</sup>, 6<sup>th</sup>, and 7<sup>th</sup> semesters.
